Home and Community-Based Service Waivers

What is a Medicaid Home and Community-Based Services Waiver?

Medicaid home and community-based services waivers allow people with disabilities and chronic conditions to receive care in their homes and communities instead of in long-term care facilities, hospitals or intermediate care facilities. These programs are called waiver programs because, under current law, eligible people with disabilities and chronic conditions are entitled to facility-based care, but home- and community-based care is considered optional. Therefore, states must apply for “waivers” from the federal government in order for Medicaid to provide home and community-based services. Waivers allow individuals with disabilities and chronic conditions to have more control of their lives and remain active participants in their community.

Medicaid provides funding for and is ultimately responsible for all of Ohio’s nine waivers. In state fiscal year 2012, waivers provided alternative access to long-term care to almost 80,000 Ohioans.

What is “Level of Care”?

A level of care is one component of Medicaid eligibility in order to approve enrollment on a Medicaid waiver or authorize Medicaid payment to a nursing facility.

A person who wants to be enrolled on a Medicaid waiver must meet the specific level of care that is required for that waiver. All individuals must meet and exceed the requirements of a Protective level of care, which includes a need for assistance with instrumental activities of daily living (IADLs) and/or supervision of one activity of daily living (ADL) or medication administration.

There are currently two levels of care associated with Medicaid waivers:

1. Intermediate Care Facility for persons with Mental Retardation (ICF-MR) level of care. This level of care includes a presence of a substantial developmental delay or a severe, chronic disability. A Medicaid waiver that requires an ICF-MR level of care provides services as an alternative to institutional care.

2. Nursing Facility-Based (NF-Based) level of care. A Medicaid waiver that requires a NF-Based level of care provides services as an alternative to nursing facilities, hospitals, or rehabilitation facilities. This level of care includes the Intermediate and Skilled levels of care:

- Intermediate level of care includes a need for assistance with ADLs, medication administration, and/or a need for at least one skilled nursing or skilled rehabilitation service.
- Skilled level of care indicates a higher level of need than the Intermediate and ICF-MR levels of care and include presence of an unstable medical condition and a need for a specific amount of skilled nursing or skilled rehabilitation services.

ODJFS determines the level of care for all waivers it administers.
ODJFS contracts with a case management agency to provide case management services.

The area agencies on aging determine the level of care for ODA waivers. ODA administers this waiver under the direction of ODJFS.

The PASSPORT Administrative Agencies act as regional administrators and provide case management services.
